twin-tube tunnel has historically served as a vital passage through the Pir-Panjal Range connecting the Kashmir Valley and Leh with the rest of India. The Border Roads Organisation (BRO) has carried out extensive renovations of the 1956-built tunnel, the defence ministry said in a state-

It acts as an alternate route to National Highway 44. Instead of levelling allegations in press conferences, Gandhi should move courts and lodge cases if he believes that there was any wrongdoing, Patra said.He noted the BJP had repeatedly moved courts and received favourable judgments in its demand for an investigation into the charges of corruption against the previous Congress-led UPA government.

Mehta pointed out security concerns and said Malik couldn't be taken to Jammu for the trial.

The law officer accused Malik of "playing tricks" for having asked to appear personally and not engaging a lawyer. Mehta said Malik was not an ordinary criminal and showed a purported photograph of Malik sharing the dais with terrorist Hafiz Saeed. The top court said it could order trial to take place inside the jail besides asking the judge to come to the national capital for the proceedings. The bench, however, noted all the accused persons in the matter had to be heard before it passes an order. Mehta said Malik physically appearing in the Supreme Court had raised security concerns previously. The bench said Malik could be allowed to appear virtually in the apex court proceedings and posted the matter on November 28.The CBI in the meantime has been directed to amend its petition and implead all accused persons as respondents.In 2023, Mehta wrote to then Union Home Secretary Ajay Kumar Bhalla flagging a "serious security lapse" after Malik was brought to the Supreme Court to appear in a case.

Malik, serving life sentence in a terror-funding case, was brought to the high-security apex court premises in a prison van escorted by armed security personnel without the court's permission. Voicing surprise at his presence, Mehta informed the apex court there was a procedure for high-risk convicts to be allowed into the courtroom to argue their case personally. The CBI said Malik, the top leader of the Jammu and Kashmir Liberation Front, was a threat to national security and cannot be allowed to be taken outside the Tihar jail premises. The apex court on April 24, 2023, issued notices on the CBI's appeal following which the incarcerated JKLF chief wrote a letter to the registrar of the Supreme Court on May 26, 2023 seeking permission to appear in person to plead his case.An assistant registrar took up his request on July 18, 2023 and said the apex court would pass necessary orders - a decision the Tihar jail authorities reportedly misconstrued to allow Malik to appear and argue his case.

Mehta referred to the CBI's contention in its appeal against the trial court order to bring Malik to Jammu for in-person examination of the witnesses in the kidnapping case, and said under Section 268 of the CrPC a state government may direct certain people to not be shifted from the confines of a prison. On September 20, 2022, a special TADA court in Jammu directed Malik to be physically produced before it on the next hearing for him to cross-examine prosecution witnesses in the kidnapping case. The CBI challenged the trial court order before the Supreme Court as appeals in TADA cases are only heard by the top court. Rubaiya was abducted near Lal Ded Hospital in Srinagar on December 8, 1989 and freed five days later after the then BJP-backed V P Singh government at the Centre released five terrorists in exchange. Mufti, who now lives in Tamil Nadu, is a prosecution witness of the CBI, which took over the case in early 1990s.Malik is lodged in Tihar jail after he was sentenced by a special NIA court in May, 2023 in a terror-funding case.

The ministry will ensure that no person remains homeless in Ladakh," Khattar, who also holds the housing and urban affairs portfolio, told reporters in Leh.He also said that financial assistance has been provided to all the street vendors under the PM Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) scheme, and all efforts will be made to ensure that no one is left out.

In Leh, the minister received a comprehensive overview of the operations of the power and housing departments, including their achievements. Expressing satisfaction with their performance, he assured all possible support to overcome the challenges posed by the region's tough terrain.On waste management and worker safety, he emphasised Ladakh's goal of achieving 100 per cent processing of waste materials."I was presented a detailed project report on this. I also stressed the importance of improving the working conditions of 'Safai Mitras' to eliminate occupational hazards," Khattar said.

Instructing the officials to expedite the preparation of detailed project reports (DPRs) for the water supply and sewage treatment plant (STP) projects in Leh and Kargil, Khattar said,"Timely completion of these DPRs is crucial for the smooth implementation of the projects which will enhance the quality of life in both the regions."Addressing the challenges faced by the power department during the winter months, Khattar assured that the UT's additional power demand will be met from the Government of India's surplus quota to ensure uninterrupted supply.

He also promised to resolve manpower issues in the power department at the earliest. The Ladakh administration submitted estimates worth Rs 1,080 crore under the Revamped Distribution Sector Scheme, with approvals expected shortly, the minister said. Stating that the ongoing projects under the PM Deendayal Package would be completed by December, Khattar announced plans to set up power supply and distribution lines to Nubra Valley and Zanskar Valley, which will significantly enhance energy availability in these regions. He also assured that efforts are being made on a war footing to address the bottlenecks hindering different project implementation.

Jammu petrol pumps...

School Education (DSE) has also issued a circular prohibiting minor students from driving motor vehicles, including two-wheelers and fourwheelers, to school. The poster, first displayed at petrol pumps in the Gandhi Nagar area on the Jammu-Pathankot highway reads, "No fuel for minors"."The poster, which specifically focuses on minors riding twowheelers without helmets or four-wheelers, is aimed at ensuring the safety of children," said an employee of the petrol pump.

This step has drawn praise from residents and encouraged the authorities to take proactive measures. On November 14, two young boys died while another was critically injured after a tragic collision between two vehicles near the Tengpora area in Srinagar. This incident sparked a debate on driving by minors and road safety in the valley. Following another accident in Srinagar last week, in which two teenage boys died and two others were injured after their car rammed into a stationary truck, the DSE issued an order prohibiting minor students from driving motor vehicles, including two-wheelers and four-wheelers, to school.

"It has come to notice that some underage students are driving vehicles while going to schools or coaching centres. Such an act has the potential of causing road accidents, endangering public safety, and is also in violation of the provisions of the Motor Vehicle Act," the DSE said in a circular issued on Thursday.It further said, "In view of the above, it is impressed upon Heads of Institutions of all government and private schools & coaching centres to implement these instructions strictly. They should keep a close vigil to ensure that no underage student is allowed to attend the institution while driving any motor vehicle, including twowheelers or four-wheelers.'

Such students must not be permitted entry and their parents should be informed accordingly, the circular added. The directive further instructed schools and coaching centres to ensure proper sensitisation of students and parents about the dangers and risks involved in underage driving. Awareness programmes on age restrictions and traffic rules should be organised in collaboration with the traffic police, it said."Parents and guardians should be educated through PTMs (parents-teachers meetings) about the consequences of underage driving and their responsibilities," it

Additionally, schools and coaching centres are required to monitor parking areas and entry points to ensure compliance, it said." Any instance of a minor driving a vehicle should be immediately reported to the concerned authorities. They should also regularly coordinate with the Traffic Police to enforce strict measures," the circular said. The directive emphasised activating all road safety and school safety clubs to raise awareness in schools." All government and private schools & coaching centres must strictly ensure the implementation of the above circular instructions in letter and spirit. Any violation of the instructions shall invite legal action under the Motor Vehicle Act and relevant laws, including the withdrawal of recognition and registration of the institution," it said.

has floated tenders for constructing a shopping complex in Muthi Camp Phase II. Ten shops will be constructed soon and allotted to these shopkeepers," he said. Political parties, including the BJP, PDP and Apni Party, and several Kashmir Pandit organisations condemned the JDA's action and called for the construction of new shops for the displaced community to help them sustain their livelihood. Pointing to his demolished shop, its owner Kuldeep Kisroo said, "Instead of helping us survive by providing better facilities and financial support, this government has snatched our bread and butter by bulldozing our shops."

Jav Lal Bhat, another shopkeeper who set up his shop in a tin shed in 1991, said, "How can we feed our families when we are solely dependent on the earnings from these shops? We urge the Lieutenant Governor and the Chief Minister to intervene and give us justice." Another shopkeeper, Jawahir Lal, described the demolition as "sheer hooliganism". He said, "No notices were served to us for the demolition." President of the Muthi migrant camp Anil Bhan criticised the timing of the demolition. "It should have waited for another month as the relief department is already constructing shops for them within the camp. This unfortunate incident could have been avoided," he said.

PDP chief Mehbooba Mufti shared a clip of the affected shopkeepers on X and urged Chief Minister Omar Abdullah to address the issue with compassion and urgency." Heartbreaking scenes emerge as Kashmiri Pandit shopkeepers stand helplessly by the rubble of their demolished shops, reportedly brought down by the JDA without prior notice. This act further deepens their sense of alienation and loss," she said on X.BJP Spokesperson G L Raina, who visited the site and met the affected families, said, "This visibly seems to be a revenge action soon after the return of the NC-Congress government headed by Chief Minister Omar

"JDA should have provided alternatives to these families. The government must stop targeting this hapless community," he said.Apni Party General Secretary and former legislator Vijay Bakaya expressed dismay and questioned the intentions of the JDA." Many shops being run by Kashmiri Pandit migrants in Muthi for nearly 30 years have been demolished. If these shops had to be removed for any legitimate reason, notice should have been given and alternative locations provided. This highhanded action by the authorities is most condemnable," he said.
